I hereby declare and confirm that (i) the information given in this Application Form is true, accurate and complete in every aspect and no facts have been suppressed or mis-stated. (ii) I have read and understood the Terms and Conditions (as amended by Card Protection Plan Limited ("CPP") from time to time) in the use of policy and agree to be bound by the same. (iii) I understand that the benefits of CPP Card Protection Select shall only be effective following premium payment and subject to acceptance and approval of this application by Card Protection Plan Limited. (iv) I can decide to cancel the policy within 21 days from the policy start date. If the policy is cancelled, subject to the absence of claims or use of services during the period, the total premium will be refunded. After this 21-day cooling-off period, the premium will not be refunded. (v) CPP will automatically renew the policy and collect the premiums from the card specified above ("Pay Card") on the renewal date unless I advise CPP not to. (vi) there is no 21-day cooling-off period for my policy renewal. (vii) CPP can instruct the issuer of Pay Card to debit the card for all premiums due and payable by me, and if CPP cannot effect payment of the premiums from Pay Card, CPP can collect the premiums from any alternative registered card at CPP's discretion.
